Kia ora,

We refer to your information request below. Hamilton City Council provides the following response.

Your request:

Are you able to provide community patrol reporting (including police patrols if provided to the Council) for the Victoria Street (up to Bryce Street and Collingwood Street), Ward Street, Worley Place and Collingwood Street area? If possible could this information be provided for the past 3 months and include the following: Type of incident, Incident Date and Day of Incident, Time of Incident and address the incident was responded to.

Our response:

City Safe have a range of patrol deployments, called patrol areas, which are based on a combination of calls for service, identified emerging risk areas, planned events, safety demand and visibility equity. The patrol area known as **Garden Place, Victoria St Mid** is an area that includes Garden Place, Ward St and Worley Pl and also includes Victoria St up to London St).

This is the patrol area most closely aligned with geographic area you have outlined in your request. Set out below are the number of calls for service responded to and the number of proactive interventions undertaken by City Safe patrols in this patrol area during the period 1 February 2024 through until 30 April 2024.

We are unable to provide the additional information you request without considerable research and collation of data. We have looked at charging for this information, but it would impact the daily duties of staff therefore in part we are refusing in accordance with s17(f) of LGOIMA – Substantial collation.
