**Your request:**

The following request for information is made under the terms of the Local Government Official Information and Meetings Act 1982.  
What is the number of alcohol outlets per capita for each local board area?  
The information sought in this request is to be used as part of a report by Newstalk ZB into alcohol harm. As the information will be used to ensure a greater understanding of alcohol availability in communities, I ask that any fee is waived.
