We refer to your information request below. Hamilton City Council provides the following response.

**Your request:**

*So many cones all along Glenview Terrace and around Hamilton in general. How much does HCC pay to have a cone on the road per day?*

**Our response:**

The work that you have identified in Glenview Terrace was for State Highway 3 resurfacing for Waka Kotahi NZTA not HCC, it was for a two-week period from 6 – 15 October as night works.

If there are specific works around Hamilton that you would like further details on, we can provide this. However for the costing of road cones, traffic management is provided for in project budgets as a total, noting that traffic cones are not a separated costing in these budgets, so we are unable to provide the specific value of expenditure relating to the use of road cones. All operational and maintenance tasks undertaken on or near roads are also subject to traffic management requirements.
