Our response:

Below is a breakdown of records Council has found regarding parking fines for council vehicles over the 2022-2024 period including total numbers and locations.

All fines received by Hamilton City Council Fleet are paid by the driver responsible for the infringement.

If a parking infringement was to be placed on the vehicle windscreen, which is typically how notices are issued, and the driver pays for this directly, Council would not receive a mailed infringement reminder. The numbers below therefore may not necessarily reflect all infringement notices.
