**Our response:**

Hamilton City Council (HCC) have carried out a search of our records under the name Classic Developments Waikato Ltd. We can confirm based on the search that we do not hold this information. Under s17(e) of LGOIMA – this information doesn't exist.

However, in light of the above, contact was made with Waikato Regional Council (WRC) to see if this information may sit with them. WRC has advised that they received a similar request from Waikato District Council (WDC) regarding a similar query from You. WRC have been able to assist with a submission dating back from 2021 under Puketaha Urban Development Ltd (Moeraki Farm Ltd and Burton Trust) which has been provided to Waikato District Council who will be responding back based on this submission and information received.

As such Hamilton City Council is unable to response to this request but Waikato District Council will be providing a response to you regarding this request.
