Kia ora,

We refer to your information request below. Hamilton City Council provides the following response.

Your request:

What extend of disrepair is required before something is done?
Fairfield road footpaths leading to Woodstock school have been re surfaced while being in a far better condition than Heaphy Terrace.
I would have thought that multiple tree roots cracking up the pavement. The areas that have lost the hard surface and are now dirt and gravel would warrant some form of remediation.
Is it possible to have a copy of maintenance and inspection reports regarding Heaphy terrace from 2010-2024.

Our response:

Thank you for bringing this to Council's attention.

Sections of the footpath on Fairfield Road were renewed earlier in the 2024-25 financial for several reasons i.e. age, condition, number of faults, damage due to tree roots. All these factors trigger a renewal of a footpath. Prioritisation of similar aged/damaged footpaths are based on usage/ foot traffic. Due to the high foot traffic being near a school, the renewal of the footpath was done earlier.

There are also sections of Heaphy Terrace that have also triggered renewals for the current financial year due to the same factors. All works will be complete prior to the end of the financial year which is June 2025.

We are unable to provide copies of 'maintenance and inspection reports' due to the complexity and substantial collation involved with extracting this information from the system for the period of time you have requested. If you are able to narrow the scope of this request to a shorter timeframe, we may be able to provide this. Until then we are refusing this part under s17(f) LGOIMA – substantial collation. We did consider charging but even with this it would take staff away from their daily duties.
