Here you can find in the report the FTE of staff for each report under the Personnel costs for the Annual Report 2023 – 2024 it is on page 200 - 201. Each report the page number will differ but it will be under personnel costs.

*At balance date, the Council employed 1,105 full-time employees (2023: 1,115), with the balance of staff representing 168.44 full-time equivalent employees (2023: 166.62). A fulltime employee is determined on the basis of a 40 hour working week.*

As such we will be refusing this request under s17(d) of LGOIMA – this information is already publicly available.
