Kia ora,

We refer to your information request below. Hamilton City Council provides the following response.

Your request:

On reviewing the material this morning, I note there have been no fines issued in top ten streets.

Are you able to say if there were any \$750 fines elsewhere and any equipment seizures in top 10 streets or elsewhere, and how many.

Our response:

No infringement notices with a \$750 fee were issued during the five-year period 2021 to 2025.

Noise control officers, alongside the Police, may remove equipment like stereos and amplifiers if the owners don't reduce excessive noise to a reasonable level for 72 hours after a written direction has been issued.

There were 188 seizures of stereos/speakers over the past five years. A further 251 seizures were attempted but the Police were unavailable at the time to support. The following table provides the number of actual or attempted seizures related to the top 10 properties.

Please see the answers to your request below:

1. *The names of (and complaint numbers received about) the top 10 noisiest streets in Hamilton over the past 5 financial years.*

See attached spreadsheet. The year 2025 runs from 1 July 2024 to 14 January 2025.

2. *What is the primary problem in each of these streets in that period when it comes to noise complaints?*

Stereo and / or people noise.

3. *How has HCC been responding to these complaints and at what cost?*

A noise control officer investigates noise complaints, if the noise is assessed as excessive, then an excessive noise warning is issued. If the direction is not complied with, then the equipment making the noise is seized with the assistance of the police.

4. *What powers does HCC have to make people dial down excess noise? What fines can the council impose? What else can be done?*

Issue the excessive noise warning and if necessary seize the equipment making the noise.

In situations of on-going noise at a property, a process is initiated involving the issue of a formal warning, notification, and discussion with the property owner, and if necessary, the issue of an abatement notice. Contravention of the abatement notice may result in the issue of a \$750 infringement.

5. *How many fines have been handed out for noise-related matters in each of the top ten streets in five years and what is their total value? What is the total value of all noise-related fines?*

No fines have been issued in any of the top ten streets over the five-year period.

6. *Does HCC have any general comment to make on the volume and nature of noise complaints in Hamilton?*

No
