2. What does the chip do and what does it cost?

The 120L red bin, 240L yellow bin and 23L food bin are all fitted with a Radio Frequency Identification (RFID) tag. The tag links the bin to a property in conjunction with the serial number on the outside of the bin.

The RFID tag also allows the bin to be scanned at the time of emptying.

The cost of the RFID tag is included in the charge HCC pays for the bin and is not separated out, so we are unable to break this cost down for you.
