Kia ora,

We refer to your information request below. Hamilton City Council provides the following response.

Your request:

I would like to request information regarding the requirements for event permits within Kirikiriria. Specifically, I am interested in understanding: Is a valid first aid certificate a standard requirement for all event permits issued by Hamilton City Council for events held in public spaces, such as parks or river areas? If so, could you please provide details of the policy or guidelines that outline this requirement? Also, are there any circumstances or exceptions where the requirement for a first aid certificate might be waived or modified for small-scale events with limited crew and budget?

Our response:

For events, no matter what size, the organisers need to provide a Health and Safety Plan; including first aid considerations. It is up to the organiser to identify their risks and control them as appropriate.

There are many events that have different types of first aid responses. Council's template provides a guide to what needs to be considered. Where an organiser advises they will have a first aider(s) on site, as part of our due diligence, HCC will ask to see the first aid certificate(s) for the named first aider(s).

Below are the health and safety points that are in our Terms and Conditions.

Health and Safety

- It is the Hirer's responsibility to ensure that the requirements of the Health and Safety at Work Act 2015, as it applies to the Hirer's intended use of the Facility, are met. The Hirer is responsible for the safety of their guests.
- The Hirer must immediately notify our staff of all near misses, accidents, and potential harm. We, at our sole discretion, may require a Health and Safety Plan from the Hirer prior to confirmation of the Booking.
- Failure to comply with Health and Safety requirements, or our directions will result in immediate termination of the Event.


