We refer to your information request below. Hamilton City Council provides the following response.

**Our response:**

**1. Has the Hamilton City Council carried out an analysis or modelling of how they will achieve Zero deaths on Hamilton Roads as part of the Access document?**

No. The Vision Zero is Councils safety vision around not having any fatalities and serious injuries on Hamilton's transport system. Council wants to provide a more forgiving road system that considers human mistakes and vulnerability. This approach is a direct reflection of the Road to Zero National Road Safety Strategy and the approach set out in that document which can be viewed [here](#).

**2. Where is the analysis information and how can I access this?**

As noted above, there is no data analysis.

**3. Is Hamilton City Council working with ACC to achieve this goal?**

ACC is one of many groups who are working nationally, regionally and locally to achieve the Road to Zero National Road Safety Strategy. Further information on the various supporters and their areas of focus can be found [here](#). ACC has a specific focus on Motorcycle Safety due to the number of motorcycle injuries.

Hamilton City Council works closely with ACC and our neighbouring councils (Waikato District Council and Waipa District Council x4 courses per year), to provide events and motorcycle education which is partly funded by Waka Kotahi NZ Transport Agency. ACC deliver and support a variety of motorcycle education courses through the Ride Forever programme— more information on these courses can be found [here](#).
