Hamilton City Council has not purchased any Christmas supplies. There are Christmas decorations that are stored at some of our offices/locations and reused each year.

The external cost to host the end of year staff Christmas party was \$25,516.

Hamilton City Council's office shut down was from 3pm on the 22 December 2023 till Monday 8 January 2024. Staff who are required to operate our facilities and infrastructure (e.g. zoo, pools, water and wastewater treatment plants) are not part of the shutdown. CE Lance Vervoort, Andrew Parsons, David Bryant, Louise Lukin, Sean Hickey took an additional week from the shut down period. For the avoidance of doubt, staff affected by the shut down are required to use their Annual leave for the non-statutory days during this period.

Our contractors go into our emergency After Hours process that is standard through out the whole year, they get called to attend emergencies only. Their rates are set in their contract as the normal emergency after hours call out fee. It is not different during Christmas.

Hamilton City Council did not make any parking fine increases over the Christmas period.
