Kia ora,

We refer to your information request below. Hamilton City Council provides the following response.

**Your request:**

*To that end I wanted to ask, under the Local Government Official Information & Meetings Act: Can you provide an itemised breakdown of what the \$700,000 needed to move the bus stop is being spent on?*

**Our response:**

The scope of the project that you refer to is wider than relocation of a bus stop. It also includes the installation of a new bus shelter and the construction of a raised signalised crossing to improve accessibility and safety for pedestrians, along with other related works. Staff are currently working through the construction design and safety audit processes, so the estimate below is not finalised.

The draft engineers estimated cost breakdown reflects the entirety of the project as follows:

Earthworks -	\$ 2,000.0
Drainage -	\$ 40,000.0
Concrete Work (including kerb & channel) -	\$ 52,000.0

Footpath & Paved Areas -	\$ 86,000.0
Fencing -	\$ 2,000.0
Traffic Signals -	\$ 160,000.0
Traffic Management	\$ 130,000.0
Contingency -	\$ 91,500.0
<b>Construction estimate</b>	<b>\$ 610,000.0</b>
<b>Total Project Budget</b>	<b>\$ 700,000.0</b>
