We refer to your information request below. Hamilton City Council provides the following response.

Your request:

I am interested to know for the 2022/2023 financial year and the 2023/2024 financial year thus far:

- 1. How much money has Council spent on construction and maintenance of cycleways and cycle infrastructure?*
- 2. How much was the contribution from Waka Kotahi New Zealand Transport Agency for those cycleways and cycle infrastructure?*

If possible:

- 1. How much money has Council spent on construction and maintenance of roadways?*
- 2. How much was the contribution from Waka Kotahi New Zealand Transport Agency for those roadways?*

I note a similar request previously answered in December 2022 (LGOIMA 292890). However, I note that this request is for a different time period and covers more than only raised safety platforms and cycle wands and associated road markings in cycle lanes.

Our response:

My apologies it seems that I went to send you, your response and have missed inputting your email. Please see out two responses below.

General notes:

- Please find below information in response to your requests that is readily available. We are not able to gather data for the full time period that you have requested unless we undertake significant work, and a charge would need to be made for this additional work to occur.
- The information for 23/24 is based on actual spend to end of December 2023.
- We are gathering the information on maintenance of cycleways and cycle infrastructure and will provide that information as soon as possible.

1. How much money has Council spent on construction and maintenance of cycleways and cycle infrastructure?

The following table provides information readily available on construction of cycleways and cycle infrastructure. Most of the transport projects are multifaceted and therefore the information below may include some non-cycleway works – equally we have many ‘roading’ projects that also have a cycling component to them which has not been captured in the information below. We are unable to break down the costs any further without significant work.

Please note: Our Transport team do not breakdown their projects via road and cycleway – they are combined as an overall project. We are unable to accurately

separate the two costs. The Number that we have provided for the cycleway maintenance, construction and contribution from Waka Kotahi are from our micro-mobility data, so this includes walkways and cycleways.

We ask that you please bare with us as we are still working on some numbers for this request. We are hoping to get the rest of the information to you by 16 February 2024.

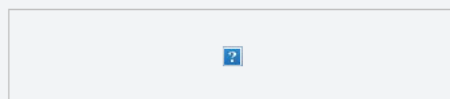
