We refer to your information request below. Hamilton City Council provides the following response.

Your request:

1. *How many requests for official information (LGOIMA) did the Council receive in the year 2023?*
2. *How many of them were handled within the statutory timeframe of 20 working days?*
3. *Out of all responses to requests for official information in 2023, how many of them were made publicly available (e.g. on your website)?*
4. *How many of all the requests for official information in 2023 were refused on the grounds that these requests were "frivolous or vexatious or that the information requested is trivial" (see Section 17 (h) of Local Government Official Information and Meetings Act 1987)?*
5. *Were the people informed that their requests for information were refused under Section 17 (h) LGOIMA?*

Our response:

1. How many requests for official information (LGOIMA) did the Council receive in the year 2023?

459 LGOIMA's from 1st January till 31 December 2023.

2. How many of them were handled within the statutory timeframe of 20 working days?

375 LGOIMA's were supplied within the original 20 working days. Some of the LGOIMA's that were over the 20 working days, were extended under the appropriate extension reason.

3. Out of all responses to requests for official information in 2023, how many of them were made publicly available (e.g. on your website)?

65 LGOIMA's are currently on the website for 2023, we will be adding more to the website as we work through them. Hamilton City Council did receive a large amount of CCTV request that sit under LGOIMA, these kinds of request have person information in which we will not be uploading to the Hamilton City Council website due to Privacy.

4. How many of all the requests for official information in 2023 were refused on the grounds

that these requests were "frivolous or vexatious or that the information requested is trivial"
(see Section 17 (h) of Local Government Official Information and Meetings Act 1987)?
