Kia ora,

We refer to your information request below. Hamilton City Council provides the following response.

Your request:

I am seeking information from Hamilton City Council to compile a 'whole of New Zealand' picture of the extent of the dog control issue across the country.

To achieve a nationwide picture, I am seeking information from all councils across New Zealand and a number of other organisations / volunteer groups directly involved in the management of dogs. The information sought does not enable the identification of an individual/s and therefore complies with the Privacy Act 2020.

Let me assure you that this is a not intended to find fault with or pass judgement on organisations that have either a responsibility for managing this issue, or those that have volunteered to assist. The purpose is to quantify the issue at a national level. I am happy to provide the finding to your organisation.

While this is simply a request for information, if it helps you, I am happy for it to be referred to as a Request for Information pursuant to the Local Government Official Information and Meetings Act 1987, or alternately the Official Information Act 1982. Can you please provide the following information, ideally in either an excel or .csv file format.

- Number of dogs that were dealt with over the 2023 calendar year by your organisation, grouped by: -
 - Month,
 - Town or Suburb in which they were located in / dealt with
- The reason for their needing to be managed by your organisation, i.e.: Where they
 - Impounded (Included Wandering and Welfare reasons)
 - Relinquished by owner.
 - Abandoned
 - Other
- The number of dogs (by month): -
 - Returned to owners,
 - Adopted/fostered by month,
 - Transferred to other organisations for rehoming / fostering etc.
 - Euthanised / destroyed, either by your organisation or by another organisation that carried out this work having received the dog directly or indirectly from your organisation.
